To Whom It May Concern;

According to (N.J.S.A.) 18A:36-39 (P.L. 2013, c44) the school is required to notify you of the following.

Please be aware that all students who use an electronic device on the Sussex County Charter School for Technology's network and the corresponding online software (Google Classroom, Oncourse, Gmail, etc.) that is provided by the school for academic purposes are monitored. While on campus, the school can maintain a log of where and for what a student uses the school provided computer. The school can access that school computer during the day as needed to verify the activities of a student.

While off campus, any student who uses the software provided by the school can be monitored ONLY for those applications that are provided by the school. This is to verify the academic activities of a student.

Accordingly, students will only be allowed access to school computers or software after parental acknowledgement of this information. This is only required to be an acknowledgement of the law and your protections and is not considered consent. Your acknowledgement ensures that the school has met the requirement of the law by informing you through this notice. However, if this signed parent acknowledgement is not returned, then the student will not be permitted to use the school's network or software/hardware, according to N.J. law.
